4. Sealed bids must be submitted to the office of Nepal A.P.F Hospital Balambu, Kathmandu Procurement section on 12:00 Hour on 2077/02/16. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2077/02/16 at the office of Nepal A.P.F Hospital Balambu, Kathmandu Procurement Section. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security amounting to above-mentioned in respective column, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the day shall be considered as the last date the same as specified for the original last date of bid purchasing/ submission.

If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No.: 1700203, Nepal APF Hospital Balambu, Kathmandu, office code No: 314053501 at Rastriya Banijaya Bank Ltd, Teku Branch and submit the receipt of the deposited amount of cash along with the bid.
