4. Sealed bids must be submitted to the office of Nepal A.P.F Hospital Balambu, Kathmandu Procurement section on 12:00 Hour on 2077/01/15. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2077/01/15 at the office of Nepal A.P.F Hospital Balambu, Kathmandu Procurement Section. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security amounting to above-mentioned in respective column, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing and./or submission falls on a government holiday, then the day shall be considered as the last date the same as specified for the original last date of bid purchasing/ submission.
7. The purchaser reserves the rights to accept or reject any bid and to annual the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to the Bidders.
