5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egg on or before 12:00 noon, on 07th August, 2020.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 07th August, 2020 at the office of APFNWSC Halchowk, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
