1. Armed Police Force Nepal Welfare Service Center Halchowk, Kathmandu, Nepal invites electronic bids from Nepalese eligible bidders for the construction of following **Works as specified in table (2)** under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO website www.bolpatra.gov.np/egg.
3. The bidder can download the bidding documents from PPMO's website www.bolpatra.gov.np/egg. The cost of bidding document is **Rs.5000.00 (non refundable)** which should be deposited in respective Project's Revenue Account **as specified in table (1)** till November 13, 2020.
4. The Bidders should follow the electronic bid submission procedures mentioned in **ITB 18 (21.1 b of Single Stage Two envelop bidding document)** of bid document.
5. Pre-bid meeting shall be held at Armed Police Force Nepal Welfare Service Center Halchowk, Kathmandu, Nepal **at 12:00 pm on November 3, 2020.**
6. The electronic bids must be submitted to Armed Police Force Nepal Welfare Service Center Halchowk, Kathmandu, Nepal through PPMO website www.bolpatra.gov.np/egg **on or before 11:00 AM on November 17, 2020. The submission of hard copy is not entertained.**
7. The bids will be opened in the presence of Bidders' representatives who choose to attend **at 11:05 AM on November 17, 2020.** Armed Police Force Nepal Welfare Service Center Halchowk, Kathmandu, Nepal. Bids must be valid for a period of **90 days** after bid opening date.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (with latest revision) and as per **ITB 27** of bid documents during examination, evaluation and comparison by the **[date and Time]**. The bidder who does not provide the clarification of its bid by the **[date and Time]** set by the employer will be rejected.
10. Only eligible bidders with the following Key Activities: should participate **as specified in table (2)**.
11. Matters not covered in this notice shall be in accordance with bid document, Public Procurement Act 2063 (with latest revision), Public Procurement Regulation 2064 (with latest revision), Electronic Procurement Directives 2074 and other prevailing Law.
