

5. Pre-bid meeting Shall be held at Armed Police Force, Nepal Welfare Service Center, Halchowki, Kathmandu, 2078/10/27 at 13:00 Hrs.
6. electronic bid must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon, on 2078/11/10, Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidder's representatives who choose to attend at 13:00 hrs on 2078/11/10 at the office of Armed Police Force, Nepal Welfare Service Center. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a scanned copy of the bid security in PDF format, which shall be valid for **30 days beyond the validity period** of the bid.
8. If Pre-bid meeting date / last date of purchasing / submission / or Opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The purchaser reserves the rights to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to the bidders.
