8. The bids will be opened in the presence of Bidders' representatives at 11:05 AM on December 18, 2022 at respective office as specified in table (1). Bids must be valid for a period of 90 days after bid opening date.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

The bidder must provide any clarification asked by the employer as per sub-clause 4 of clause 23 of Public Procurement Act 2063 (with latest revision) and as per ITB 27 of Single Stage Two envelope bidding procedure of bid document during examination, evaluation and comparison by the date and time given. The bidder who does not provide the clarification, of its bid by the date and time set by the employer will be rejected.
