5. Electronic bids must be submitted to the office of The Armed Police Force, 7 Baidhanath Brigade Headquarters, Attariya Kailali, through PPMO's e-GP system www.bolpatra.gov.np/egpon or before **12:00** hrs. on 08th Falgun, 2080. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00** hrs. on 08th Falgun, 2080, at the office of Armed Police Force, Nepal No. 7 Baidhanath Brigade Headquarters, Attariya Kailali, Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum below mentioned respective coloum. Which shall be valid for 30 days beyond the validity period of the bid.
