- 1. Armed Police Force, Nepal Headquarters, Procurement Division invites **electronic** bids from eligible bidders for the procurement of below mentioned Goods under National competitive bidding Single Stage Two Envelope procedures as specified in Public Procurement Act and Regulation.
- 2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 23 of the Bidding Document.

- 5. Pre-bid meeting shall be held at Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu, Nepal at 13:00 hrs.,10th Mangsir, 2081.
- 6. Electronic bids must be submitted to the office of the Armed Police Force, Nepal Headquarters Procurement Division through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hrs. on, 24th Mangsir, 2081. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. on 24th Mangsir, 2081 at the office of Armed Police Force, Nepal Headquarters, Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum below mentioned respective column which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
