6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on January 16, 2020 at the office of APFNWSC Halchowk, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.
