7. The bids will be opened in the presence of Bidder's representatives who choose to attend at 13:00 hrs on 2078/05/09 at the office of APFN HQ, Procurement Division. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to above-mentioned in respective column, which shall be valid for 30 days beyond the validity period of the bid.
